Annual Employment Survey 2015

Executive Summary

The Annual Employment Survey provides an analysis of employment levels in Industrial (including Primary Production) and Services companies under the remit of IDA Ireland, Enterprise Ireland and Údarás na Gaeltachta¹. This 2015 Annual Employment Survey report looks at employment trends over the 10-year period 2006 to 2015. The main findings of the 2015 survey are set out below.

Overall Employment

Total permanent, full-time employment in agency-assisted companies operating in the Industrial and Services sectors amounted to 341,078 in 2015, an increase of 20,148 jobs (6.3%) on 2014 employment levels and continuing the trend of positive growth in employment since 2011. For the first time since the recession, full-time employment in all agency assisted firms outstripped the peak employment level prior to the recession in 2007. There are now 16,438 more full time jobs in agency assisted firms, a 5.1% increase over the 2007 level.




Figure A: Total full-time and part-time/temporary jobs in agency assisted firms, 2006 to 2015

Gross job gains (i.e. jobs created) for 2015 are 33,880, which is up slightly on the 2014 figure of 33,168 and gross job losses (13,732) are at their lowest level for more than a decade. The net change for permanent, full-time jobs, therefore, equals 20,148 in 2015. Part-time and temporary

employment in agency assisted firms increased by 2,347 jobs in 2015 to reach 46,365, the highest number recorded in the ten year time series.




Figure B: Jobs gains, losses and net change in full-time and part-time employment in all agency assisted firms, 2006 to 2015

Total full-time employment among Irish-owned companies amounted to 164,257 in 2015, an increase of 9,165 jobs (5.9%) over 2014. This increase continues the four-year trend of positive employment growth for Irish-owned firms following the loss of 27,431 jobs between 2007 and 2011. Irish-owned companies account for 48.2% of total full-time employment in agency-assisted firms in 2015 compared with a 51.8% share in 2006. There was an increase of 4.4% (1,107 jobs) in part-time and temporary (Other jobs) jobs in 2015 to 26,333, giving three years of consecutive growth.

Among foreign-owned companies, total full-time employment amounted to 176,821 in 2015, an increase of 10,983 jobs (6.6%) over the previous year and the highest employment level recorded over the 10 year series. Full-time employment in 2015 has surpassed peak employment prior to the recession in 2007 by 11.8% (18,610 jobs). Foreign owned firms now account for 51.8% of total employment in agency assisted firms compared with 49% in 2006. Foreign-owned part-time temporary employment increased by 1,240 jobs (6.6%) since 2014.

Regional Employment

The Border Midlands and West (BMW), Dublin, and the South and East (S&E) regions saw increases in employment levels over 2014 levels, giving a fifth year of employment growth for those regions. The South and East (S&E) region excluding Dublin remains the largest region in employment terms, accounting for 140,340 jobs, or 41%, of total agency employment, followed by the Dublin region with 125,898 full-time jobs (37%) and the Border, Midland and West (BMW) region with 74,840 employed (22%). While employment in the Dublin and South and East

regions are at their highest levels over the period 2006 to 2015, the BMW region is still below peak employment of 75,687 in 2007.

Irish-owned firms located in the South and East region accounted for 42.4% (69,589 jobs) of total Irish-owned full-time employment in 2015, up from 57,087 in 2010 or an increase of 21.9% from the lowest point in 2010 and reached peak employment over the 10 year period. The BMW region accounted for 26% (42,722 jobs) of Irish-owned employment in 2015, and employment has decreased since 2006 by 4.3%. Dublin-based Irish client companies accounted for 51,946 jobs in 2015 (31.6% of the total), up 3,370 (6.9%) on 2014 and only 147 jobs less than the 2007 peak of 52,093 jobs.

Foreign-owned firms located in the South and East accounted for 70,751 jobs in 2015 (40% of all regions), up 791 jobs (1.1%) on the previous year, and reached peak employment for the decade. In overall terms, while agency assisted employment has increased in the BMW region, the BMW region's share of full-time employment in foreign-owned companies is 18.2% in 2015 compared with 19.2% in 2006. Permanent jobs in the BMW region were at the highest level in 2015 (32,118) and had increased by 5.8% (1,775 jobs) since 2006. Foreign-owned client companies in the Dublin region accounted for 73,952 jobs, the highest number recorded over the decade. Dublin has the highest employment of the three regions accounting for 41.8% of nationwide employment.

Sectoral Employment

The sectoral employment breakdown shows evidence of continuing structural change in agencyassisted companies towards Services sectors. Full-time employment in all Industrial sector companies increased to 194,732 in 2015, up from 185,887 in 2014 (a rise of 8,845, 4.8%). Services employment increased more significantly to 146,346, up from 135,043 in 2014 (a rise of 11,303, 8.4%).

Total full-time jobs in the Irish–owned industrial sector amounted to 107,430 in 2015, up from 102,299 in 2014, a net gain of 5,131 jobs (5%). The sub-sectors with the most significant net jobs gains in 2015 were: Food (1,294 jobs), construction (847 jobs) and machinery and equipment (557 jobs). Proportionately, the sub-sectors that gained most employment were: medical and dental instruments and supplies (14%) and non-metallic minerals (11.4%). There were no negative net changes (i.e. net losses) reported in the Irish-owned Industrial sectors in 2015.

A total of 56,827 full-time jobs were recorded in the Irish-owned Services sector in 2015, with a net gain of 4,034 jobs (7.6%) over 2014. The sub-sectors with the highest net employment gains in 2015 were: Business Services (1,437 jobs) and Computer Consultancy Activities (1,048 jobs). Proportionately, the sub-sectors that gained most employment were: Computer Programming (14.4%) and Financial Services (10.3%). There were no negative net changes (i.e. net losses) reported in Irish-owned Services sectors.

In the foreign-owned industrial sector, total full-time jobs amounted to 87,302 in 2015, up from 83,588 in 2014, with a net gain of 3,714 jobs (4.4%) since 2014. The sub-sectors with the most significant net jobs gains in 2015 were: Computer, Electronic and Optical Equipment (1,786 jobs) and Chemicals (1,275 jobs). Proportionately, the significant sub-sectors that fared best in 2015 over 2014 in terms of employment net change were: Computer, Electronic and Optical

Equipment (10.7%) and Rubber and Plastics (8.8%). The sectors showing the most significant negative net changes in the foreign-owned Industrial sectors in 2015 were medical and dental instruments and supplies (-204 jobs) and drink and tobacco (-136 jobs)

A total of 89,591 full-time jobs were recorded in the foreign-owned Services sector in 2015, with a very substantial net gain of 7,269 jobs (8.8%) over 2014. The sub-sectors with the highest net employment gains were: Computer Programming Activities (1,944 jobs) and Financial Services (1,577 jobs). Proportionately, the sub-sectors that gained most employment were: Other Information and Communication Services (55.5%) and Other Services (30.9%).

Introduction

This document sets out the results of the 2015 Department of Jobs, Enterprise and Innovation (DJEI) Annual Employment Survey. The survey is an annual census of employment in all Manufacturing and Services companies supported by the enterprise development agencies (IDA Ireland, Enterprise Ireland, and Údarás na Gaeltachta) and was formerly undertaken by Forfás until its integration with DJEI in 2014. The survey has been carried out each year since 1972. DJEI, in line with its mandate to co-ordinate the activities of Enterprise Ireland and IDA Ireland, continues to carry out the survey with the co-operation of Enterprise Ireland and IDA Ireland regional staff. Údarás na Gaeltachta carries out the survey for companies falling within its remit and provides the results for inclusion in the DJEI database. Companies formerly surveyed as Shannon Development companies have been incorporated into either the IDA Ireland or Enterprise Ireland client portfolios since 2013.

The data is presented by nationality of ownership rather than in terms of the parent development agency, and hence the cohort of foreign-owned firms includes food and beverages and natural resource subsidiaries of overseas firms that are supported by Enterprise Ireland.

The structure of the main body of the report is as follows:

- Section 1 provides overall employment trends in Manufacturing and Services sectors, the results of which are broken down on the basis of Irish and foreign ownership. Data on part-time, temporary and short-term contract employment are also provided for companies within the remit of Enterprise Ireland, IDA Ireland and Údarás na Gaeltachta.
- Section 2 provides a regional analysis of permanent/full-time employment.
- Section 3 analyses permanent/full-time employment on the basis of industrial sector.


It should be noted that employment figures in this document may differ from those previously reported at year-ends due to factors such as the inclusion of new companies on the agency client lists, revisions made by companies during the survey or the transfer of companies between Irish and foreign ownership at the end of each survey year.

Detailed tables are provided in the Appendix.



- Total permanent, full-time employment in agency-assisted companies operating in the industrial and Services sectors amounted to 341,078 in 2015, an increase of 20,148 jobs (6.3%) on 2014 employment levels. For the first time since the recession total full time employment in agency assisted firms outstripped the peak employment level prior to the recession in 2007. There are now 16,438 more full time jobs in agency assisted firms, or a 5.1% increase, over the 2007 level.
- Total full-time employment among Irish-owned companies amounted to 164,257 in 2015, an increase of 5.9%, or 9,165 additional jobs, over 2014 and not far from peak employment in 2007 of 166,429 jobs. Irish owned firms account for 48% of total employment in 2015 compared with 51% in 2006.
- Among foreign-owned companies, total full-time employment amounted to 176,821 in 2015, an increase of 10,983 jobs (6.6%) over the previous year and the highest employment level recorded over the 10 year series. Full time employment has surpassed peak employment in 2007 prior to the recession by 11.8% (18,610 jobs). Foreign owned firms now account for 52% of total employment in agency assisted firms compared with 49% in 2006.

- Part-time/ temporary or short-term contract employment in both foreign and Irish owned companies increased since 2014, and employment levels for both in 2015 were at the highest level over the 10 year period shown above.
- In total, there were 46,365 jobs of a temporary or part-time nature recorded in agencyassisted companies in 2015 representing an increase of 2,347 jobs since 2014.
- There were 26,333 part-time/ temporary workers in Irish owned firms in 2015, an increase of 4.4% since 2014.
- Irish-owned firms accounted for a 50% share of all part-time workers in agency assisted firms in 2006; this share increased to 57% in 2015.
- There were 20,032 part-time/ temporary workers in foreign-owned firms in 2015, an increase of 6.6% since 2014.
- Between 2006 and 2015, the annual growth rate in part-time workers in Irish-owned firms was 3.9% compared with 0.7% in foreign-owned firms





- Permanent full-time employment in Industry² was recorded as 194,732 in 2015. The • number employed in Industry has increased by 12% (20,109 jobs) since 2011, the lowest employment level in the 10 year time series. Employment has fallen by 10.2% from a high of 216,919 in 2006 to its current level. This represents a decrease of 22,187 jobs since 2006.
- Industry accounts for the majority of jobs in agency client companies (57% of full-time • jobs) in 2015, but this share has declined from a 68% share of total employment in 2006.
- The Services sector has grown by 42% over the period 2006 2015, with permanent fulltime employment reaching a high of 146,346 jobs in 2015. Employment in Services has increased every year since 2006, with the exception of 2009 when the sector shed 7,715 jobs over 2008. Over the decade employment in the services sector increased by 42% (43,041 jobs), offsetting the losses in the Industry sector.
- In 2015, employment in the Services sector accounted for 43% of total employment • compared to 32% in 2006.



1.4Trends in Permanent, Full-time Employment by Industrial and Services
Sectors in Irish and Foreign Agency-Assisted Companies, 2006-2015



- The majority of employment in Irish owned firms is in the Industrial sectors and for the first time the majority of employment in foreign owned firms is in the Services sector, with a 51% share of total employment.
- Over the past decade the Services sector has increased its share of total employment in Irish and foreign companies, so that it now accounts for 35% and 51% of total agency employment respectively.

1.5 Trends in Permanent, Full-time Employment in Irish and Foreign Agency- Assisted Companies by Industry and Service Sectors, 2006-2015



- In the Industrial sector, Irish-owned companies accounted for 55% of full-time employment in 2015 down from a 57% share in 2006. Between 2006 and 2015, there was a decline of 15,273 jobs in the sector, with heavy jobs losses between 2007 and 2011 (27,994), but growth in employment of 12,092 jobs since 2011.
- In the Services sector, foreign-owned firms accounted for 61% of permanent full-time employment in 2015 without much fluctuation over the decade.
- Foreign-owned Services firms created 25,752 extra jobs between 2006 and 2015, a 40.4% increase.
- Overall, Services companies created an additional 43,041 jobs between 2006 and 2015, offsetting job losses of 22,187 recorded in the Industry sector.




- The above table and accompanying chart documents trends in temporary and part-time • employment on the basis of Industrial and Services sectors.
- Part-time employment in the Services sector was almost on a par with employment levels in the Industry sector in 2015. Growth in part time employment has been higher in the Services sector, with a 60.5% increase since 2009 compared with 36.2% in the Industry sector.
- Between 2006 and 2015, total temporary and part-time jobs increased from 37,434 to 46,365 in 2015, the highest level recorded over the decade.
- In the Industry sector, part-time employment increased from 21,727 to 23,560 between 2006 and 2015, with peak employment in 2015.
- Temporary and part-time employment within the Services sectors has climbed fairly • steadily from 15,707 in 2006 to 22,805 in 2015 - an increase of 7,098 (45.2%).
- In 2006 the Services sector accounted for 42% of all part-time employment compared • with 49.2% in 2015.



- Figure 1.7 illustrates trends in gross job gains, gross job losses and net job change among • all agency-assisted firms during the period 2006 - 2015. The net change in employment comprises gross job gains (firms that have increased employment) less gross job losses (firms where employment numbers have decreased).
- In the period 2006-2007 agency-assisted companies recorded net job gains, followed by • net job losses between 2008 and 2010 with particularly heavy net job losses in 2009 of 31,362 jobs. Since 2011 agency assisted companies have recorded positive net job gains, with the highest positive net job change of 20,148 jobs recorded in 2015 and representing the fifth consecutive year of positive growth.
- Gross job gains of 33,880 in 2015 are at the highest level in the last decade, just above the 2006 peak. There has been a 2.1% increase in gross job gains (712 jobs) since 2014.
- In 2015, total gross job losses at 13,732 were at their lowest level in a decade and had • fallen by 9.4% since 2014.

- Figure 1.8 illustrates trends in gross job gains, gross job losses and net job change among Irish-owned firms during the period 2006 to 2015.
- The highest positive net change was recorded in 2014, with 9,320 jobs created. 2015 was the fourth successive year of positive net growth in employment for Irish–owned firms, recording a net change of 9,165 jobs, a slight decrease since 2014. The highest negative net change was recorded in 2009 with 17,470 jobs lost. In 2012, jobs gains of 12,481 exceeded jobs losses of 10,229, resulting in a net change of 2,252 jobs created indicating a return to jobs growth for the first time since 2007.
- Over the ten year period, 2006 was the year that the most jobs were created by Irishowned companies (19,904 jobs). In 2015, gross job gains in Irish-owned companies, at 16,121, had decreased by 8.4% since 2014 and by 19% since 2006.
- In 2015, gross jobs losses, at 6,956, were at their lowest level in a decade, representing a decline of 15.9% since 2014 and of 38.1% since 2006. The highest job losses in the decade at 26,811 were recorded in 2009.



- Figure 1.9 provides an overview of gross job gains, job losses and net job change in foreign-owned agency-assisted companies between 2006 and 2015.
- In 2015, the net change in jobs has increased by 26% since 2014 and has more than trebled since 2006. The highest positive net change was recorded in 2015 with 10,983 jobs created overall and the highest negative net change was recorded in 2009 with 13,892 jobs lost.
- In 2015, jobs gains of 17,759 exceeded jobs losses of 6,776 resulting in a net change of 10,983 jobs created and indicating a fifth consecutive year of jobs growth. Over the ten year period, 2015 was the best year for job creation for foreign-owned firms, with 17,759 jobs created. Gross job gains increased by 14% since 2014 and by 31.4% since 2006.
- In 2009, the highest job losses of the decade were recorded with 19,830 jobs lost. Job losses for the last three years have remained relatively stable, decreasing by 1.5% since 2014.



- The Border, Midlands and West (BMW) region saw an increase of 2,930 jobs (4.1%) from 71,910 jobs in 2014 to 74,840 jobs in 2015. The South and East region saw an increase of 8,151 jobs (6.2%), from 132,189 in 2014 to 140,340 jobs in 2015, while Dublin had an increase of 9,067 jobs (7.8%), from 116,831 jobs in 2014 to 125,898 jobs in 2015.
- In 2006, the BMW region accounted for 23.4% of total agency-assisted employment, employing 74,969 full-time people in 2006. In 2015, the BMW region accounted for 21.9% of employment, but employment in the region had decreased by 0.2% to 74,840. The South and East region accounted for a 43.1% share of total employment in 2006 compared with a 41.1% share in 2015, with employment increasing by 2,735 (2%) over the period.
- The Dublin region currently accounts for 36.9% of total agency-assisted employment, up from 33.6% in 2006. In absolute terms, employment has increased by 18,248 jobs (17%) in Dublin over the period. The highest level of employment in the Dublin region over the decade was recorded in 2015.



2.2 Permanent Full-Time Employment in Irish-Owned Agency-Assisted Companies by Region, 2006-2015

- The BMW region gained 1,868 jobs between 2014 and 2015, an increase of 4.6%. The South and East region gained 3,927 jobs, an increase of 6%, and the Dublin region gained 3,370 jobs, an increase of 6.9% over 2014.
- In 2006, the BMW region accounted for 27% of total employment, employing 44,626 fulltime staff. In 2015, the BMW region accounted for 26% of total employment, and employment had decreased since 2006 by 4.3% to 42,722. The South and East region accounted for a 41.7% share of total employment in 2006, compared with a 42.4% share in 2015, with employment increasing by 1,944 (2.9%) over the period.
- The Dublin region currently accounts for 31.6% of total Irish-owned agency-assisted employment, up from 30.8% in 2006. In absolute terms, employment has increased by 1,976 jobs (4%) in Dublin over the period.
- Growth in employment was recorded in all regions between 2014 and 2015





- Trends in permanent full-time employment in foreign-owned agency-assisted companies are detailed above in Figure 2.3. Dublin has seen its share of foreign-owned employment grow from 36.5% in 2006 to 41.8% in 2015. Employment also increased by 16,272 jobs (28.2%) over the 10 years.
- The BMW region has seen its share of foreign-owned employment fall from 19.2% in 2006 to 18.2% in 2015 and recorded gains of 1,775 jobs (5.8%) over the period.
- The South and East region saw its share of foreign-owned employment fall from 44.3% in 2006 to 40.0% in 2015, and saw growth of 791 jobs (1.1% increase) over the period.
- In 2015, employment in foreign-owned firms increased by 6.6% or 10,983 jobs over 2014.
 Of these 10,983 jobs, 5,697 (52%) were in the Dublin region, 4,224 (38%) were in the South and East regions, and 1,062 (10%) in the BMW region.
- Growth in employment was recorded in all regions between 2014 and 2015





- Figure 3.1 presents a sectoral breakdown of permanent full-time employment across all agency-assisted companies by broad sector. In 2015, employment increased by 20,148 jobs or 6.3% for all sectors over 2014. The Manufacturing sector accounted for 39% of this increase (7,910 jobs) and the Information, Communication and Computer Services sector accounted for a third of the increase (6,705 jobs)
- All broad sectors presented in Figure 3.1 show increases in full time employment since 2014. In 2015, employment in the Services sectors had increased substantially since 2006, and in Industry employment levels are lower than in 2006.
- Full time employment in Industry increased by 4.8% (8,845 jobs) since 2014 and in Services by 8.4% (11,303 jobs).
- The Manufacturing sector has gained 7,910 jobs since 2014, a rise of 4.6%, but the sector has seen a loss of 20,200 jobs, or 10.1%, since 2006.The Computer, Optical and Equipment sector saw a 9.6% increase in full-time employment, 2,004 additional jobs since 2014. The Other Information Technology and Computer Services Activities sector saw an increase of 13.5% over 2014 (an additional 1,294 jobs), and employment in this sector more than trebled since 2006. Within the Manufacturing sector the Medical and Dental Instruments and Supplies sector had employment growth of 18% or 3,555 jobs since 2006; however, employment dropped slightly (0.3%) since 2014.
- The Food sector accounts for 23.4% of employment (42,104 jobs) in the Manufacturing sector in 2015. The Food sector had an increase in employment of 3.7% since 2014 or 1,521 jobs. Since 2006, employment in the Food sector increased by 3%, gaining an additional 1,313 jobs.
- The development agencies support enterprises in the Construction, Utilities and Primary Production sectors that are internationally trading, which is a relatively small proportion of these sectors overall, and saw an increase over 2014 of 935 jobs. This category of agency-supported internationally trading enterprises has seen employment losses of 1,987 jobs, or a decrease of 11.7%, since 2006.
- With the Information, Communication and Computer Services sector, the computer programming activities sector had the largest employment growth since 2014, accounting for an additional 2,063 jobs, or a 7.7% increase.
- The Business, Financial and Other Services sector also recorded jobs growth of 8.6% or 4,598 jobs between 2014 and 2015. Since 2006, 18,294 jobs were created in this sector, an increase of 45.8%, of which 8,165 jobs were created in the Financial Services sector. The Business Services sector showed employment growth of 9.4%, and an additional 1,936 jobs since 2014.



3.2 Sectoral Proportions in Permanent Full-Time Employment in All Agency-Assisted Companies, 2006-2015

- As a share of total agency-assisted company employment, Manufacturing has fallen from 199,929 in 2006 (62% of total employment) to 179,729 in 2015 (53% of total employment).
- In the business, financial and other Services sector employment rose from 39,955 in 2006 to 58,249 in 2015 and has increased its share of total employment from 12% to 17% over the same period.
- The information, communications and computer Services sector increased its share from 20% in 2006 to 26% in 2015.
- The construction, utilities and primary production sector saw a small decrease in shares of total employment between 2006 and 2015 of 1%.





- Figure 3.3 presents a sectoral breakdown of permanent full-time employment across • Irish-owned companies by broad sector. In 2015, employment increased by 9,615 jobs, or 5.9% for all sectors over 2014.
- Manufacturing jobs increased by 4,201 since 2014, up 4.7%, and 31% of these additional • jobs were created in the Food sector. Since 2006, however, the Manufacturing sector has seen a loss of 12,985 jobs.

- The Business, Financial and Other Services sector saw growth of 6.8% in employment, or 2,181 jobs, since 2014. Over the 10 year period, this sector has seen employment growth of 38.7%, or 9,535 jobs, with the Business Services sector accounting for 6,795 (or 71%) of those jobs.
- The Information, Communication and Computer Services sector created 1,853 additional jobs since 2014, up 8.9% on 2014. Employment in the Construction, Utilities and Primary Production sector has increased by 930 jobs (7%) in 2015.

3.4 Sectoral Proportions in Permanent Full-Time Employment in Irish-Owned Agency-Assisted Companies, 2006-2015



• As a share of total Irish-owned company employment, Manufacturing has fallen from 106,133 in 2006 (65% of total employment) to 93,148 in 2015 (57% of total employment).

- The Business, Financial and Other Services sector has seen its share increase from 15% to 21% between 2006 and 2015. Employment in this sector has increased from 24,622 in 2006 to 34,157 in 2015.
- The Information, Communications and Computer Services sector has also increased their share of total employment from 9% in 2006 to 14% in 2015 with numbers employed increasing from 14,916 in 2006 to 22,670 in 2015.
- The Construction, Utilities and Primary Production sectors saw a decrease of 2% in its share of total employment between 2006 and 2015.



• Table 3.5 provides a sectoral analysis of permanent, full-time employment for Irish-owned firms in 2015, along with job gains and losses over the corresponding 2014 figures. It also provides net percentage change in employment between 2014 and 2015.

- There were net employment gains in all Manufacturing and Services sectors shown above in 2015.
- The majority (63.1%) of Irish-owned employment continues to be found in the Manufacturing sectors. This sector has seen the loss of 3,887 jobs in 2015, with job gains of 8,935 resulting in a net gain of 5,048 jobs.
- The sectors with the highest positive net change were food (1,294 jobs), construction (847 jobs), machinery and equipment (557 jobs), and non-metallic minerals (544).
- The Services sectors account for 35% of Irish agency-assisted employment. This sector created 7,009 jobs in 2015 and recorded losses of 2,975 resulting in a net gain of 4,034 jobs (7.6%).
- The sectors with the highest positive net change in absolute terms were business Services (1,437 jobs) and computer consultancy activities and computer facilities management (1,048 jobs).



- Figure 3.6 and the accompanying table present a sectoral analysis of employment in foreign-owned Manufacturing and Services companies.
- In 2015, for the first time, greater numbers are employed in the Services sector than in the Manufacturing sector in foreign owned companies
- Manufacturing has seen the largest job losses in foreign-owned employment in the period 2006 to 2015. Foreign companies in this sector have shed 7,215 jobs in this period, a reduction of 7.7%.
- The Services sectors have seen more buoyant employment numbers over the period 2006 to 2015. In similar fashion to Irish-owned companies, employment in the Business, Financial and Other Services sector saw a substantial increase, going from 15,333

employed in 2006 to 24,092 in 2015. Information, Communication and Computer Services also had a good year in 2015, with an increase of 8% over 2014.

• Foreign-owned companies employ a negligible number of employees in Construction, Utilities and Primary Production.

3.7 Sectoral Proportions in Permanent Full-Time Employment in Foreignowned Agency-Assisted Companies, 2006-2015



- Figure 3.7 depicts the proportion of employment in foreign owned client companies for each sector in 2006 and in 2015.
- Notable are the reduced share of Manufacturing jobs moving from 59% in 2006 to 49% in 2015, and the increases in the Services sectors.
- The Information, Communication and Computer Services sectors now represent 37% of total employment, compared with 31% in 2006. Similarly, the Business, Financial and Other Services sectors have increased their share to 14% in 2015 from 10% in 2006.
- Construction, Utilities and Primary Production employment shares have negligible proportions.

- Table 3.8 presents the sectoral composition of permanent full-time jobs, job gains, job losses and net employment change in foreign-owned agency-assisted companies in 2015.
- Within Manufacturing, employment grew overall by 3,273 jobs to 86,970 jobs, an increase of 4.5% over 2014. Job losses in Manufacturing of 2,957 were outnumbered by job gains of 6,680.
- Net increases in employment in the Manufacturing sectors were driven by the Computer, Electronic and Optical Equipment sector (1,786, 10.7%), as well as the Chemicals sector (1,275 jobs; 6.4%). The sectors with the largest net losses were Medical and Dental Instruments and Supplies Sector (-204 jobs; -0.9%) and Drink and Tobacco (-136 jobs; -5.9%).
- Within the Services sector, employment grew overall by 7,269 jobs over 2014 (8.8%) to 89,519 jobs.
- Key drivers of this overall increase included a 7.5% (1,944 jobs) net growth in the number employed in the Computer Programming Activities sector.
- The Services sector with the largest number of employees is the Computer Programming activities sector. This sector employed 27,809 people in 2015, followed by Financial Services with 20,464 employees.

C1 Overview of Methodology and Definitions

The Annual Employment Survey is carried out by postal survey and an extensive telephone follow-up.

In line with previous years, census returns as at 31st October for Permanent Full-time and for Temporary, Part-time and Short Term Contract employment combined were sought.

In the presentation of the results, we have reflected the nationality of any companies at the time of reporting. In the light of changes of ownership, the inclusion of new companies and the correction of identified errors, historic employment figures have been restated where appropriate. Therefore, the figures may differ from those previously reported.

C2 Definitions

- Permanent Full-Time: Employees who have been employed full time for nine months or longer or who will be on contracts of nine months or longer on 31st October 2015.
- Part-time, Temporary & Short-term Contracts: Employees who have been employed for less than 9 months in the 12 months to 31st October 2015 or who are on employment contracts of less than 9 months or employed on a casual basis.
- Job Gains: Increase in employment, on a company by company basis, arising in the survey year over and above the company's employment level in the previous year. •
- Job Losses: Decrease in employment on a company by company basis, arising in the survey year. •
- Net Change: Difference between the total job gains and the total job losses in the survey year.
